Nigerian Market Highlight: Equity, Fixed Income & Money Market Review

TUESDAY AUGUST 13TH, 2024

Equities Market

- At the end of today's trading session on the Nigerian Stock Exchange (NGX), a total of 599,246,035 shares in 11,237 deals, corresponding to a market value of NGN 13,916,167,908.23, were traded.
- Compared with the previous trading day, today's data shows 20% improvement in volume, and 18% improvement in turnover. The current market capitalization of the Nigerian Stock Exchange is NGN 55.3 trillion.
- MeCure Industries led the gainers with 9.98% share price appreciation, followed by Neimeth Int. Pharma (9.9%) & Champion Breweries (9.75). On the losing side, Oando ended the day with price depreciation of 9.97%, followed by Livestock Feeds (-8.1%) and Cornerstone Insurance Company (-7.66%).

Fixed Income & Money Market

- The system liquidity opened with a deficit of ¥509 billion. As a result, the Open Repo Rate (OPR) increased by 47bps to 36.61%, and the Overnight Rate (O/N) increased by 17bps to 36.97%.
- The T-bills market extended its positive run as the average yield declined by 0.07% to close at 25.56%. This is following buying interest across the tenors.
- The FGN bond market closed positive with the average yield down by 0.03% to 19.97%. This was driven by buying interest in the MAR-2025 (-0.01%) MAY-2033 (-0.48%), JUN-2033 (-0.24%), FEB-2034 (-0.39%) and MAR-2050 (-0.08%).
